Part A – Bidding and Contract Requirements

<u>AD1.01 (RFI's)</u>

PRE-BID RFI QUESTIONS AND RESPONSES

- Q1: Keyed Notes 6.40 (E) GRASS AREA. COMPLETELY REMOVE, REGRADE, AMMEND AND PROVIDE NEW IRRIGATION AND NEW PLANTING PER LANDSCAPE DRAWINGS AND SPECS. Between buildings A and B, B and C, and D and Parking lot, the removal of irrigation and grass will be removed. I cannot find in the landscaping plans the specs with the new irrigation other than the replacement of valves and I cannot find the types of planting going back in there. Can you provide information IF new irrigation and planting will be installed and if so, what page in the plans I can see them in?
- A1: Keyed Note 6.40 applies only to the hatched areas. Refer to updated drawings issued in this Addendum for deletion of the Keyed Note at all other landscaped areas.
- Q2: On the Playground Equipment, is the Playground Equipment owner furnished? Who is responsible for the purchase of this equipment and the installation? Are there specs of the Playground equipment (manufacturer) and if so, what page would I be able to find it?
- A2: Play apparatuses are to be CFCI. Refer to ADD01 summary for additional information.
- Q3: On page AS100 Keyed Note 6.11 PROVIDE CRACK-FILL AND SEAL COAT. CLEAN AND FILL MINOR ALL CRACKS IN ASPHALT. MAJOR CRACKS AND DEFLECT) TO BE CUT OUT AND REPAIRED AS SPECIFIED. After asphalt has had a seal coat, are we also responsible to restripe the hardcourts back to the original stage with the United States Map, basketball court and all other striping there prior to sealing?
- A3: Refer to updated sheets issued via this Addendum.
- Q4: On the accessible parking stalls. NEW ASPHALT PAVING OVER AGG BASE OVER PREPPED SUB GRADE. U.O.N. REFER TO CIVIL FOR VARYING SECTION LOCATIONS

AND REQUIRED SUB-GRADE PREPARATION. What page on the Civil Plans would I be able to obtain the specs for the new asphalt parking stalls and the specs for restriping? *No modifications to parking stalls or paving are in this project.*

- Q5: Refer to L3.1, there are some symbols of head that have no legend. Please clarify.
- A5: Refer to ADD1 L3.1.

- Q6: Please confirm that the water source is domestic.
- A6: Yes, this is domestic water.
- Q7: Please confirm that sleeve size shall be 2 times diameter of pipe inside.
- A7: The sleeve size shall be large enough to fit the pipe.
- Q8: Please confirm there is no quick coupler valve shall be used in this project.
- A8: No quick couplers
- Q9: Refer to L3.1, there is a callout for 3/4" RCV but not shown on the plan. Please clarify.
- A9: Refer to ADD1 L3.1.
