Public Hearing to Consider Support for Renewal Petition

On June 27th, 2024, Growth Public Schools submitted a petition to renew its charter. It is requesting to renew the term of its charter, which expires on June 30, 2025. Today's public hearing is the first public hearing on the Growth Public Schools renewal petition, as required by Education Code. The purpose of the public hearing is to consider the support for the charter petition from the district's teachers, other employees, and parents.

Staff are currently reviewing the submitted petition. Following the review of the petition and this public hearing, the governing board of the school district shall either grant or deny the charter within 90 days of receipt of the petition. That decision is scheduled to occur at the September 5, 2024, board meeting. The governing board of the school district shall publish all staff recommendations, including the recommended findings, at least 15 days before the public hearing at which the governing board of the school district will either grant or deny the charter. Staff is scheduled to publish this report by August 21, 2024.

The school leader will be given the remainder of this agenda item to present to the Board, with public comment and Board discussion to follow.







Diverse Student Population

GPS teachers receive extensive professional development and support throughout the year





In April 2021, GPS became the first elementary school in the nation to become a certified Powered by Compass ("PBC") School.






Exemplary Performance in Measurable Outcomes, such as:

- Staff Investment: GPS has had multiple years of 100% of staff investment in the PBC model, as measured by annual survey.
- Trust in School Leader: Trust levels at GPS are higher than 84% of schools across the country.

Community Satisfaction



GPS annually surveys its **teachers**, **staff and families** to gather data on perceptions of school culture, as well as overall satisfaction, and continuously receives high levels of positive feedback and responses on these measures.



96% of staff feel connected to the mission and vision of GPS

93% of families would rate the culture of GPS as positive.

93% of staff would rate the team culture as positive.

100% of staff enjoy working at GPS

GPS students met the threshold required to show one year of growth in Reading, and exceeded this threshold in Math.






Thank you for giving us space in your meeting to present GPS. We are excited to continue to serve students and families with a high quality option in partnership with SCUSD and the District Board.
