## Methodology

### How the survey was developed:

Using a Youth Participatory Action Research (YPAR) framework, the survey was created through Google Forms after considering what questions may best address the needs and concerns of high school students across the district.

#### How the survey was distributed:

To increase survey participation, we shared the survey via the following methods: Email, Social Media (Instagram, Facebook), Google Classroom, and in-person canvassing across all sites.

### **Goal number for survey distribution:**


Representative sample from all high schools in the district.

## **College Readiness**

### **Context of Concern**

- Students are discontent with the lack of support services regarding community college dual enrollment.
- Community college credits are no longer transferable for high school credits outside of the "Elective" category.
- On the Student Advisory Council's concern survey, students cited lack of "future life skills" classes as a top priority to address.



## **Youth-Led Advocacy**

- Collaborated with student leaders from John F. Kennedy regarding their work surrounding expanding dual enrollment services and supports.
- Met with College and Career Readiness Director, Christina Espinosa, to discuss the creation of a potential resolution focused on dual enrollment.
- Paused our work due to ongoing negotiations with SCTA and Los Rios.



### Recommendations

- We will continue to advocate for policy changes regarding college and life readiness in schools.
- Ensure the Student Advisory Council is included in future discussions regarding the development of dual enrollment related policies and procedures.





## **Gender Neutral Restrooms**

### **Context of Concern**

- Access to restrooms is a fundamental human right. We should not create an environment where students who do not identify with the gender binary must choose whether to use the male or female restroom.
- We should strive to make our campuses as inclusive and equitable as possible. We aim to create a safe space for all of our students.



## **Research on Existing Measures**

#### **Board Policy 5145.31**

- Gender non-conforming students should be allowed access to restroom facilities that align with their gender identity.
- Transgender and gender non-conforming students shall not be forced to use the restroom corresponding to their assigned sex at birth.

#### AB 1266 School Success and Opportunity Act

 Allows SCUSD students to access facilities and programs that correspond to their gender identity.



## **Youth-Led Advocacy**

- Identified California Education Codes and Board Policy/Regulations surrounding gender neutral restrooms.
- Collaborated with Capital Projects, Facilities, and Resource Management Director I (Nathaniel Browning) and Assistant Superintendent of Facility Support Services (Chris Ralston).
- Drafted Board Resolution highlighting the urgency to ensure student access to gender neutral restrooms.



### Recommendations

 Approve a future Board Resolution focused on ensuring gender-neutral restroom accessibility in a student-centered location, intended primarily for student use, within each SCUSD high school.





## **Campus Hygiene**

### **Context of Concern**

- SCUSD campuses are extremely **unhygienic**.
  - Students noted that basic restroom necessities are lacking in quality and quantity.
  - Extreme conditions noted, ex: feces on wall
  - "Terrible and rancid." SES student
- Only 11.8% of SCUSD high school students thought the bathrooms were of quality or high quality.
- **Over 51% of students** said that bathroom cleanliness impacts their daily performance.



## **Research on Existing Measures**

#### **Current Standards and Regulations:**

#### Menstrual Equity for All Act of 2021:

- 6th grade to high-school
- Should be stocked at all times
- In both mens and womens restrooms

#### • SCUSD Board Policy 5030:

- Access to restrooms with hot and cold running water,
- Soap, disposable towels and/or hand dryers, proper trash and sanitary containers.



"Pad and tampons dispensers were NEVER filled." - CKM



"Sometimes there isn't toilet paper, and almost 9/10 times there are no paper towels to dry hands and not a lot of soap." - SES



## **Youth-Led Advocacy**

- Additional **survey** conducted among all SCUSD high schools with hygiene-specific questions.
- Identified California Education Codes and Board Policy/Regulations surrounding campus hygiene.
- Met with Capital Projects, Facilities, and Resource Management Director I (Nathaniel Browning) and Assistant Superintendent of Facility Support Services (Chris Ralston).
- Drafted a Board Resolution with the hopes to present at a future date.

### Recommendations

- Ensure restroom facilities are consistently restocked with necessary material, such as toilet paper, hand soap, paper towels, and menstrual products.
- Consistent schedule for cleaning duties (frequency at which restrooms are checked, cleaned, and stocked).
- Enforce a standard for servicing, cleaning, and supplying campus facilities.





## **Environmental Sustainability**

### **Context of Concern**

- Today's children and youth, despite being least responsible for the causes of climate change, will confront its adverse impacts throughout their lifetimes.
- In 2021, the National Association of School Psychologists passed a resolution declaring that climate change negatively impacts the mental health of youth and asserts climate change education as a key factor to support student agency, self-efficacy, and resilience.



## **Youth-Led Advocacy**

- Initiative led by West Campus leader, who came to the SAC to find additional guidance and support to pass a Resolution focused on sustainable waste.
- Efforts led to a collaboration with the Sustainability Manager, Chamberlain Segrest, and Nutrition Services Supervisor, Eric DelaCruz and Director, Diana Flores.
- A final Board Resolution was drafted and reviewed collaboratively amongst the SAC, Sustainability, and Nutrition Services.



### Recommendations

- Approve Resolution No. 3419: Sustainable Waste that calls for:
  - Efforts to source practical and sustainable alternatives to the current single-use plastic utensils and supplies for the district to pursue.
  - Development of metrics to measure food waste.
  - Continued collaboration between the SAC and SCUSD leadership regarding environmental sustainability.
