**Background/Rationale:** On June 28, 2024, Sacramento Charter High School 7 submitted a petition to renew its charter. It is requesting to renew the term of its charter, which expires on June 30, 2025. The purpose of the public hearing is to consider the support for the petition from the district's teachers, other employees, and parents.

Staff are currently reviewing the submitted petition. Following the review of the petition and this public hearing, the governing board of the school district shall either grant or deny the charter within 90 days of receipt of the petition. That decision is scheduled to occur at the September 19, 2024, board meeting. The governing board of the school district shall publish all staff recommendations, including the recommended findings, at least 15 days before the public hearing at which the governing board of the school district will either grant or deny the charter. Staff is scheduled to publish this report by September 4, 2024.

**Financial Considerations:** The petitioners include budget details in their petition to renew the charter. District staff will review the petition and publish recommendations and findings.
