Meeting 5 Mar. – Apr.	<ul> <li>□ SSC approves 2025-26 School Parent &amp; Family Engagement Policy and Compact for distribution in 2025-26</li> <li>□ Share district draft <u>LCAP</u> with SSC/Community</li> <li>□ Hold <u>SSC Election</u> for 2025-26 school year, if needed</li> <li>□ Complete the Annual Evaluation of 24-25 SPSA in preparation for development of the following year's SPSA</li> </ul>
