I am here to discuss our experience with the con capping process, which is consisted of disappointment, heart ache, and frustration for myself and our family. The services of disappointment that Judah did not have space for him and he was con pped to Caleb Greenwood for the remainder of the year. With the assistance of his credible teacher and IEP team, my son was making progress academically and coming ome excited about the materials he was learning and finally able to access cognitively. He as making friends and connections with other kids and staff members at Caleb. When quiring about resuming his education at Caleb Greenwood for the following year, we ere told he would have to return to his school of residence per district policy. In an tempt to do right by our son, and to advocate for the fairness and consistency of our son's fucation, we applied for an intra district transfer permit. When the online system didn't low us to submit a permit request, we were informed by Principal Trent that she would not be offering any permits for the 24-25 year due to the SCTA contact negotiations that bould decrease 4th grade class sizes, putting that grade at or close to capacity. The this happened, my wife and I reached out to the PTSO, our school board member, the constituent services, the superintendent assistants, as well as the superintendent. There was not one solution or suggestion provided to us. We only heard many times, that "this is how to one solution or suggestion provided to us. I am here to tell you that the policies you uphold do not ke children's lives into account. After we told our son he would have to change schools GAIN, he teared up and asked "why can't they just put one more chair and one more sik in the class? Why can't they make a little roo

We also have twin first graders who we have attempted to enroll into our home school of Theodore Judah. Neither child has a spot confirmed. We have been told to wait and see what the numbers look like in August...

This is a failure to the children and families the district claims to serve and we are devastated that we can't help our children with the current district, policies, and solutions available.

We started this advocacy journey, concerned with my oldest son's mental health and access to equal and fair education, but I am now here inquiring about a solution to just get my kids into the same school. We are at risk of having our children enrolled in two, possibly three schools with unnecessary changes and disruptions to their education, social life, self-esteem, and mental health.

Enrollment numbers are not my children's fault, yet it seems like they are the ones that are being impacted by district policies that seem to focus on adults rather than students. I'm here to ask for solutions and changes in policy to meet the needs of students. If there are more children in an area than the school currently has space, that is the district's job to meet those needs and find solutions. It is not my child's burden to be pushed back and forth to schools where there is space.

I spoke at the last school board meeting and have not heard a response.

My name is Claudia Ramirez and I manage the international exchange programs at Global Ties Sacramento, a division of World Trade Center Northern California. We partner with the U.S. Department of State to implement the International Visitor Leadership Program (IVLP), a premier international exchange program that connects people from around the world with counterparts in the United States to share best practices and build important international relationships. These professional meetings reflect the participants' professional interests and support the foreign policy goals of the United States.
	I am reaching out because I am working on an upcoming international exchange visit and would like to request a meeting with the Sacramento City Unified School District Board of Education on behalf of an upcoming group. From August 23rd to 27th, Global Ties Sacramento is hosting a group of 6 international professionals from Kyrgyzstan. 	The visiting group includes a President (Association of Legal Clinics), a Director, a Deputy Chief of Party, and other emerging professionals. They speak Kyrgyz, Russian, and a little English (varies per participant) and will be accompanied by one State Department

International Visitor Liaison and two Interpreters for a total of 9 in the group.
