Recommendation:

The Superintendent is recommending the Board certify the results of the November 5, 2024, bond election within the Sacramento Unified School District (the "District").

Background/Rationale:

On November 5, 2024, the District submitted Measure D, a general obligation bond measure authorizing the issuance of not to exceed \$543 million aggregate principal amount of general obligation bonds of the District, to the qualified electors within the District. The canvass of returns shows that 55% or more of the electors voting on Measure D voted in favor of Measure D.

The Education Code requires that the Board of Education enter the election results from Measure D upon its minutes and certify those results to the Board of Supervisors of Sacramento County (the "County"). The final vote canvass from the County is attached as Exhibit "A" to the Resolution.

Upon adoption by the Board, a copy of the adopted Resolution will be sent by the District to the County Superintendent of Schools to satisfy the requirements of Education Code section 15274.

RESOLUTION NO. 3469

RESOLUTION OF THE BOARD OF EDUCATION OF SACRAMENTO CITY UNIFIED SCHOOL DISTRICT CERTIFYING ALL PROCEEDINGS IN THE NOVEMBER 5, 2024 GENERAL OBLIGATION BOND ELECTION (MEASURE D)

WHEREAS, the Board of Education ("Board") of the Sacramento City Unified School District ("District") previously adopted a resolution ordering a bond election and authorizing necessary actions in connection therewith ("Bond Resolution"); and

WHEREAS, the Bond Resolution was duly delivered to the Sacramento County Registrar of Voters; and

WHEREAS, an election was thereafter called and held on November 5, 2024 ("Bond Election") for the purpose of voting on a measure known as "Measure D" for the issuance of general obligation bonds of the District in the aggregate principal amount of \$543,000,000 ("Bond Measure"); and

WHEREAS, prior to the Bond Election, notice of the Bond Election was duly given; and

WHEREAS, the Board has received from the Sacramento County Registrar of Voters the statement of votes cast at the Bond Election ("Certificate of Election"); and

WHEREAS, it appears from the Certificate of Election, which is attached hereto as <u>Exhibit A</u>, that fifty-five percent (55%) or more of the votes cast on the Bond Measure were in favor of issuing the aforementioned bonds.

NOW, **THEREFORE**, THE BOARD OF EDUCATION OF THE SACRAMENTO CITY UNIFIED SCHOOL DISTRICT DOES HEREBY FIND, DETERMINE AND CERTIFY AS FOLLOWS:

- **Section 1.** That entry be made upon the minutes of this meeting that the Bond Measure has been approved by fifty-five percent (55%) or more of the votes cast at the Bond Election.
- **Section 2.** That all proceedings of the District in connection with the Bond Election have been accomplished according to law.
- **Section 3.** That the Clerk of the Board is hereby requested to deliver, or arrange for delivery of, a copy of this Resolution to the County Superintendent of Schools.
